REVISED CIRCULAR

AEPC's participation in "India Tex Trend Fair (ITTF)" Tokyo, Japan $(15^{th}-17^{th}\ March,\,2022)$

Dear Member,

Apparel Export Promotion council (AEPC) has decided to participate in **India Tex Trend Fair**, **Tokyo**, **Japan**. The Japan India Industry Promotion Association (JIIPA) has scheduled to organize the India Tex Trend Fair in Tokyo, Japan from 15th to 17th March, 2022, offering a comprehensive platform to Indian Apparel manufacturers. India and Japan have signed CEPA (Comprehensive Economic Partnership Agreement). This gives customs duty free imports of garments from India to Japan.

About ITF:

The India Trend Fair is an exclusive Business Matching Event which gives an opportunity to exporters to showcase their products and supply capabilities of value added products with special emphasis on the products designed to suit Japanese fashion trends and requirements. The visiting buyers would include manufacturers, wholesalers, trading companies, importers, select and specialist shops, department stores, volume and online retailers etc.

About JIIPA

Japan India Industry Promotion Association (JIIPA) is a Tokyo based NPO affiliated by Tokyo Metropolitan Government to promote trade between Japan & India.

Facilities planned for the Show: Built in booth of around 9 SQM equipped with the following:

- 3 mt. x 3 mt. pre laminated partition with Octonorm system and 2.7 mts. of height
- Needle punch carpet (depending upon Covid norms)
- Fascia board with company name
- Running garment hanging rail of 9 mtrs length
- Hangers (150 pcs.)
- Round Table (one no.) plus Chairs (2 nos.)
- Dustbin (1 Pc)
- Spot Light (6 Pcs)
- Power Socket (1 Pc)

Value- added services planned for the show:

- Business-matching for apparel participants & to invite 3-5 buyers per exhibitor on daily basis.
- Engaging consultants / agents for follow-ups
- Bilingual website of the ITTF 2022 to generate enquiries and disseminate the same among the participants.

Following additional services are planned by the fair organizer to the participants:

- Free services of interpreters for the participants
- High speed Wi-Fi facility on complimentary basis
- Visa recommendation letter
- Fair catalogue in Japanese & English language
- Advertising the trade fair extensively, and targeting potential buyers, designers.

Eligibility for financial assistance under Market Access Initiative (MAI) scheme:

As per Notification no. K-11020/9/2021-E&MDA dated 19th July, 2021 of Ministry of Commerce & Industry, Department of Commerce (E&MDA) Division reg. eligibility for availing MAI grant with following conditions:

"a maximum of three participations in a particular trade fair/ exhibition would only be eligible for MAI assistance, i.e. members who have availed assistance three times (including past cases) for a particular fair / exhibition thereafter have to participate in that fair on their own. Further MAI funding support shall only be provided to a member for a maximum of two MAI events in a year."

Reimbursement of airfare:- Further, the Council would propose to Dept. of Commerce for sanction of grant on account of reimbursement of airfare (economy class) if it is approved by Ministry of Commerce, accordingly, regular director / partner / proprietor / regular officer of the company on senior managerial position of participating firm/co. shall be eligible for reimbursement of airfare as per MAI guidelines under para 6 (ii) of the Market Access Initiative Scheme 2021 issued by the Ministry of Commerce from time to time.

MAI assistance shall be permissible to regular director/ partner/proprietor / regular officer of the company on senior managerial position. Assistance would not be available to exporter of foreign nationality or holding foreign passport.

Non-MAI Exhibitor shall not be eligible for reimbursement.

<u>Participation Charges</u>: The participation charges does not include air-fare or any other kind of personal expenses (logistics etc.)

The last date for submission of applications is 28th February, 2022

Since the project is under MAI scheme approved by Ministry of Commerce, only one booth would be allotted to one company at discounted price of Rs. 1.60 lakhs. However, if any company wants to purchase additional booth in the same name, then the additional booth may be given at normal price of Rs. 2.80 lakhs (without MAI grant).

For applying double booth, the exhibitor would pay AEPC an amount of Rs. 4.40 lakhs.
