Please note that the competent authority has extended the last date for receiving the annual subscription without late fee for the financial year 2026-27 from member exporters and registered exporters up to 30.06.2026. The Council approved the following RCMC charges for the Financial Year 2026–27.

• New membership for Women Entrepreneur	Rs. 8,000/-+ GST (Entrance charges of Rs.1000/- extra)
• New membership for Young & Start-ups Entrepreneur	Rs. 8,000/-+ GST (Entrance charges of Rs.1000/- extra)
• New Membership for others	Rs. 12,000/-+ GST (Entrance charges of Rs.1000/- extra)
• RCMC renewal charges for registered exporters having turnover up to Rs. 5 crore:	Rs. 12,000/+ GST
• RCMC renewal charges for registered exporters having turnover above Rs. 5 crore and up to Rs. 50 crore:	Rs. 15,000/ + GST
• RCMC renewal charges for registered exporters having turnover above Rs. 50 crore:	Rs. 20,000/+ GST
RCMC renewal charges for member exporters	Rs. 20,000/+ GST

\*Present applicable GST is 18%, # Subscription once paid will not be refundable or transferable.

The last date for making payment of annual subscription (without late fee) for the year 2026-27 is 30<sup>th</sup> June, 2026.
