As mentioned in our circular bearing number AEPC/HO/MAGIC/EP 2025 -26 dated 22nd May 2025, Apparel Export Promotion Council (AEPC) is participating in Sourcing at Magic Fair to be held from 18th to 20th August, 2025, which will take place in LAS VEGAS, USA.

Please note that the <u>last date for filing applications has been extended to 20th June 2025</u> and the terms and conditions of the same are as mentioned below.

3. Why you should exhibit in Sourcing at Magic, USA?

USA has been a very attractive market for Indian Apparels. Main items of export to USA are – Men/Boys/Women's/Girls/Kids jerseys, pullovers, cardigans, waistcoats and similar articles of cotton, knitted or crocheted; trousers, bib and brace overall, breeches and shorts of cotton and synthetic fibres; T.shirts and shirts and singlets and other vests of textile material.

RMG imports into the USA have increased in the last five years. USA's import from India has also increased in these past years. Import from India's in 2020 was 3201.6 USD mn., which increased to 4933.1 USD mn. in 2024. India captured a share of 4.5% approx. in 2020 which has now increased to 5.9% in 2024. At a category level according to 2024, Knitted RMGholds a much better acceptance in USA as compared to woven apparel.

5. Eligibility for financial assistance under Market Access Initiative (MAI) scheme:

The Apparel Export Promotion Council has submitted a proposal to the concerned Ministry, requesting the MAI Grant for participation in the Sourcing at Magic, USA. The Ministry's decision on our proposal is awaited and cannot be considered approved unless confirmed in writing.

The MAI Grant, provided by the Government of India in accordance with established norms, has not yet been approved for this event. However, AEPC encourages exporter members to proactively explore financial assistance available under their respective State Government schemes and take full advantage of the benefits offered.

The MAI Grants as and when received will be disbursed to the eligible exhibitors as per MAI Norms.

It is pertinent to mention that as per Notification no. K-11020/9/2021-E&MDA dated 19th July, 2021 of Ministry of Commerce & Industry, Department of Commerce (E&MDA) Division reg. eligibility for availing MAI grant with following conditions:

"a maximum of three participations in a particular trade fair/ exhibition would only be eligible for MAI assistance, i.e. members who have availed assistance three times (including past cases) for a particular fair / exhibition thereafter have to participate in that fair on their own. Further MAI funding support shall only be

provided to a member for a maximum of three MAI events in a year. In case of exporter belonging to SC/ST/Women and the exporter is having FOB Value of exports less than Rs. 50 crore in a year, 5 participations in a particular event is allowed."

Reimbursement of airfare: - Further, the Council would propose to Dept. of Commerce for sanction of grant on account of reimbursement of airfare (economy class) if it is approved by Ministry of Commerce, Govt. of India. Accordingly, regular Director / Partner / Proprietor / regular officer of the company on senior managerial position of participating firm/company having 12 months membership with Council, exporter having minimum FOB value of exports Rs. 50 Lakhs but below Rs. 50 Cr. in the preceding financial year shall be eligible for reimbursement of airfare as per MAI Guidelines under para 6 (ii) of the Market Access Initiative Scheme 2021 issued by the Ministry of Commerce from time to time. **Non-MAI Exhibitor shall not be eligible for reimbursement.**

(On receipt of MAI grant from the Ministry, the booth cost will be subsidized and the balance amount would be refunded to the eligible exporters as per MAI norms)

- 6. The deadline for submitting the application along with payment is 20th June, 2025.

- b) Please ensure to share the UTR Details in case of online payment, failing which your participation would not be considered even if payment is already made.
- 8. Booth Packages: The following booth facilities shall be provided to the participating exhibitors.
 - 9 sq.mtr. Stall
 - One round table and 3 chairs
 - 16 Rods OR 16 Shelves (1 meter each)
 - Name Fascia
 - Carpet
 - 6 Track light with power
 - 4 Water bottles per day
 - Dustbin
 - Laptop charging point
 - 150 Hangers

Note: Additional displays, advertising, branding, modified fascia, hangers, additional electrical installation and other services can be provided at additional cost.

9. Guidelines for allotment of the booths:

- i. All participants who have paid the full participation fee on time would be considered for allotment of booths through draw of lot by AEPC.
- ii. No change in the booths, once allotted would be entertained under any circumstances.
- iii. The decision of Chairman-EP (AEPC) / Chairman (AEPC) would be final and binding in case of any dispute.
- iv. The participation is on **FIRST-CUM-FIRST SERVED (FCFS)** till all booths are sold and the allotment of stalls shall be done through draw of lot basis.

10. Waitlist:

In case, applications are over-subscribed, a waitlist will be maintained, which would be considered on FCFS basis. Applicants are advised to ensure that they possess will obtain necessary visa to enter USA. No request for refund will be entertained by AEPC if for any reason whatsoever visa is not granted.

11. Withdrawal Terms & Conditions:

Terms & conditions for withdrawal will be as follows:

- **Pre-Draw of Lot Withdrawal :**If the exporter withdraws before the Draw of Lot, or prior to receiving the visa invitation letter from the fair authority or entering into a contract with the fair authority, a forfeiture of **Rs. 25,000/- + applicable GST** charges will apply.
- **Post-Draw of Lot Withdrawal :**If the exporter withdraws after the Draw of Lot, or after the visa invitation letter is issued by the fair authority or after entering into a contract with the fair authority, **100**% **forfeiture** of the amount paid will apply.

12. Issuance of Visa Invitation Letter by the Fair Authority -

Visa Invitation Letters will be issued to exhibitors under the following conditions:

- Visa Invitation Letters will only be provided to exhibitors who have paid full payment and have entered into the contract with the fair authority. No cancellations will be permitted once this condition is met.
- The exhibitor must submit a copy of their US Embassy appointment letter. The appointment must be scheduled at least 30 days prior to the start of the show.
