Apparel Export Promotion Council (AEPC) has decided to participate in **India Apparel & Accessories Fair 2026, Tokyo, Japan**. The Japan India Industry Promotion Association (JIIPA) has scheduled to organize the India Apparel & Accessories Fair in Tokyo, Japan from 29<sup>th</sup> to 31<sup>st</sup> July, 2026, offering a comprehensive platform to Indian Apparel manufacturers.

#### **1. About India Apparel & Accessories Fair 2026:**

The India Apparel & Accessories Fair is an exclusive Business Matching Event which gives an opportunity to exporters to showcase their products and supply capabilities of value added products with special emphasis on the products designed to suit Japanese fashion trends and requirements. India Apparel & Accessories Fair has earned recognition as a premier trade fair in Japan for the Indian Garments & Home Furnishings Export Industry. During the three-day fair, exhibitors will showcase their **Spring / Summer 2027-28 collections**. The visiting buyers would include manufacturers, wholesalers, Chain Stores, Departmental Stores, Trading Companies, importers, select and specialist shops, Retailers, Boutique buyers etc. India Apparel & Accessories Fair looks forward to building bridges of partnerships between the Indian Exporter community and Japanese Buyers.

#### **2. Why you should exhibit in IA&AF, Tokyo, Japan?**

**Japan has been a very attractive market for Indian Apparels. Main item of export to Japan are** - Woven and Knitted Garments, Inner Cloths, Sweaters, Cardigans, Jackets, Casual Wears, High Fashion Garments, Occasional Wears, Sports Wears (Men's Wear, Women's Wear, Baby/Kids Wear) (**Fashion Accessories** like) Shawls, Stoles, Scarves, Mufflers, Socks, Leggings, Tights, Glovers, Ties, Hat, (**Home Textiles** like) Made-ups, Cushion Covers, Bed Linen, Bed Covers, Interiors, Goods, Curtains, Towels, Decorative Articles, Floorings and Ethnic Craft, (**Leather items** like) Jackets, Coat, Hand-gloves, Belt, Bags, wallets, card wallets, purse, Shoes, Leather Accessories, (**Fabrics** like) Wool, Jute, Cotton, Silk, Linen, Chiffon, Nylon, Velvet, Polyester, Taffeta, Denim, Rayon, Georgette, Satin etc.,

Japan is the 4th largest readymade garment importer in the world, there is a huge untapped trade potential in the RMG sector which India must extensively and aggressively focus on

building India-Japan trade. India hold a strong business opportunity in Japan reflected by the fact that China, which has been a dominant garment supplier to Japan, has witnessed a decline in the past 5 years giving

Significant advantage to India. Moreover, the duty-free access for Indian RMG post Indo-Japan CEPA agreement as against an approximate 9% for China and Turkey is a big advantage for India. Japan's import from India has increased in the last five years. Import from India's in 2021 was 224.6 mn. Which increased to 282.4. mn. in 2025. India captured a share of 0.9% in 2021 which has increased to 1.2% in 2025.

7. Financial Assistance under the Market Access Support (MAS) Schemes under Export Promotion Mission (EPM) of the Central Government Regarding:
  - 7.1. All members who wish to avail financial assistance under the Export Promotion Mission (EPM) are advised to carefully review and promptly fulfil the eligibility requirements prescribed under the Market Access Support (MAS) Schemes of the Central Government. These requirements are outlined in the official guidelines issued by the Government and are available on <https://www.trade.gov.in/pages/Market-access-Support> and is currently available on the link (<https://content.trade.gov.in/EPM-Scheme-Guidelines/Guidelines-for-Support-for-Market-Access-under-the-Export-Promotion-Mission.pdf> ). Members are further advised that non-compliance with these requirements may result in rejection of claims
  
  - 7.2.. These guidelines are subject to revision and will be updated from time to time. Members are advised to remain apprised of the same and take necessary action accordingly in a timely manner. Members are advised to keep themselves updated in this regard by visiting <https://www.trade.gov.in/>
  
  - 7.3. The Apparel Export Promotion Council has submitted, or is in the process of submitting, a proposal to the concerned Ministry seeking grants under the **Market Access Scheme (MAS)** of the **Export Promotion Mission (EPM)** for participation in the above-mentioned event. The Ministry's decision on the proposal is currently awaited, and no grant shall be deemed sanctioned or approved unless and until formal written confirmation is received.
  
  - 7.4. Upon receipt of the MAI/MAS grant from the Ministry, the booth cost will be subsidized and the balance amount will be refunded to the eligible exporters accordingly.
  
  - 7.5. **The number of exhibitors eligible to receive financial assistance under the schemes framed under the Export Promotion Mission (EPM) shall be determined by the Government of India through the concerned Ministry(ies). Financial assistance will accordingly be extended only to the number of exhibitors as approved by the Ministry. In the event that the number of exhibitors approved for financial assistance is fewer than the number of exhibitors who actually participated in the event, assistance from the Government shall be granted strictly on a first-come, first-served basis. Members are therefore advised to submit their applications promptly and in full conformity with these provisions, keeping in view that assistance will be limited to the extent sanctioned.**
