Procedure to pay Annual Subscription from 01st Apr, 2022 from e-RCMC portal of DGFT.

Members are requested to refer Trade Notice No. 27 dated 30.11.2021 (click here to view) and Trade Notice No. 35/2021-2022 dated 24.02.2022 (click here to view) issued by DGFT regarding electronic filing of Registration cum Membership Certificate (RCMC) / Registration Certificate through the common digital platform of DGFT. The objective of the platform is to provide an electronic, contactless single window for the RCMC/RC related processes including application for fresh/ amendment/ renewal of RCMC. The authenticity of the online issued RCMC shall be verifiable by the

exporter through login in to exporter profile at https://dgft.gov.in. The details for RCMC/ RC issued using the DGFT portal will be reflected instantly in the profile of the exporter.

In this context, it is informed that from 1stApril 2022, it will be mandatory for the exporters to file Registration Cum Membership Certificate (RCMC)/ Registration Certificate (RC) applications (for issue/renewal/amendment) through the common digital portal of e-RCMC Platform.<u>Member will</u> have to login on DGFT Website www.dgft.gov.in by clicking on login button. Member who are already registered on DGFT, may use the same user ID & Password for login. If member is not registered on DGFT portal they have to press the register button & get themselves registered first. Digital signature Certificate or Adhaar based signature will be required to submit the application for renewal or amendment of RCMC on DGFT Portal.

As registering authority, AEPC is already on-boarded and will adopt the e-RCMC platform of DGFT as a single point for handling RCMC related processes from 1stApril 2022.
