# Sub: AEPC's participation in MODA UK, Birmingham, United Kingdom 11<sup>th</sup> – 13<sup>th</sup> August, 2013

## Dear Member,

In order to explore UK Apparel Market, AEPC is participating in **MODA UK in Birmingham**, **UK** to be held from **11-13 August 2013**, which will take place in Hall 17-20 of the NEC Birmingham in UK.

#### **ABOUT MODA:**

Moda is organized by ITE Moda Ltd, part of ITE Group Plc. It is the UK's largest fashion trade event, regularly playing host to more than 1,450 brands covering women's wear, men's wear, footwear, lingerie & swimwear and accessories. It is open to trade buyers.

Moda takes place twice a year in February and August. The August event, showcasing spring/summer 2014 collections, will take place on 11-13 August 2013.

Moda is the UK's largest trade show for the fashion industry, aimed at buyers from stores of all sizes across the women's wear, men's wear, lingerie & swimwear, footwear and accessories sectors. Entrance to the show is also free of charge to agents and distributors.

You may take advantage to tap this huge US\$ 21 billion English apparel market. India's apparel exports to UK were US\$ 1,484 million in 2012.

#### **VENUE:**

The fair would be held in Hall 17-20 at National Exhibition Centre (NEC) Birmingham, Birmingham, B40 1NT, UK.

#### **DATES:**

11 – 12 – 13 August, 2013 (Sunday, Monday and Tuesday)

#### PARTICIPATION CHARGES AND LAST DATE:

This is a right opportunity for you to explore the large apparel market of UK. The booth package and other details are as follows:

Participation charges of approx a 9 SQM with basic equipped booth : Rs. 2,65,000/Early bird discount (Up to 24.05.2013) : Rs. 15,000/Amount Payable (Up to 24.05.2013) : Rs. 2,50,000/Amount Payable (after 24.05.2013) : Rs. 2,65,000/-

This does not include other costs like airfare, hotel stay and other incidentals.

Kindly note: Cheques & Part payments are not acceptable. Payment can be made by Demand Draft or Pay Order only.

#### **MDA Grant**

This project is under Marketing Development Assistance (MDA) scheme. Market Development Assistance (MDA), as announced by the Ministry of Commerce and as amended from time to time, would be applicable. As per the new MDA Guidelines, all exporters having export turnover of less than Rs. 15 Crore in the year 2012-13 and membership with AEPC for more than one year continuous would be eligible. MDA assistance is not available, in case export is nil or negligible in the preceding year, the application would be subject to the total MDA guidelines issued by the Ministry of Commerce from time to time. #### **PROFILE OF EXHIBITORS:**

The applications would be considered only after due scrutiny of the applications by the management of the Council, since this fair caters to high profile buyers for men's, women's & fashion accessories. Those exporters with large production capacity & better end product would be given preference. The fair authority may maintain different sections for Women's wear, Men's wear & accessories, etc.

The interested members must furnish the following information while applying for the fair:

- 1. Product Profile with Good Quality/High Resolution Photographs
- 2. Company Website
- **3.** Major Strengths of the company
- 4. Type of Cliental you are looking to attract during the show

The application form is attached herewith. You are requested to kindly send the participation fee by way of **Demand Draft/Pay Order** in favour of "APPAREL EXPORT PROMOTION COUNCIL" with duly filled-in application form to A.E.P.C., Apparel House, Institutional Area, Sector – 44, Gurgaon – 122 003.

#### **GUIDELINES FOR ALLOTMENT OF THE BOOTHS:**

- 1. All participants who have paid the full participation fee in time would be considered for allotment of booths through alphabetical order / as per order of fair authority.
- 2. The decision of SG-AEPC/Chairman (EP)-AEPC would be final in case of any clarification.
- 3. No change in the booths, once allotted would be entertained under any circumstances.
- 4. The applications received with full participation charges shall be scrutinized by the Management of the Council for suitability for the fair, and then confirmation for the booth shall be given.

#### **WAITLIST**

In case, applications are over-subscribed, a waitlist will be maintained. Applicants are advised to ensure that they possess necessary visa to enter UK. No request for refund will be entertained by AEPC if for any reason whatsoever visa is not granted.

## **CANCELLATION CHARGES**

The exporter who has applied for participation in the Fair, the withdrawal will be subject to following:

- A. 25% of participation charges will be forfeited if the exporter withdraws before the participation is confirmed by the Council and other participant on the wait list confirms their participation. However, the forfeiture will be 35% of participation fees, in case, there is no other participant on the wait list.
- B. 45% of the participation charges will be forfeited if the exporter withdraws after confirmation of participation by the Council and other exporters on wait list confirms their participation. There will be forfeiture of 65% of participation fee if no other exporter is on the wait list.
- C. 100% forfeiture in case of no show of the fair.
- D. Non-grant of relevant visa shall not qualify for any relief.
